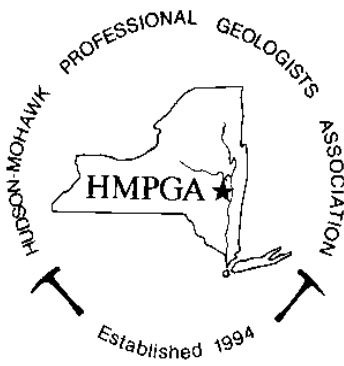

SUMMARY OF CORPORATE MEMBERSHIP OPPORTUNITY
