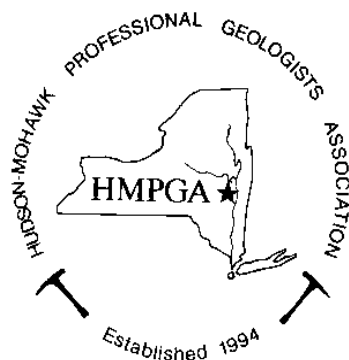

### ***SUMMARY OF CORPORATE MEMBERSHIP OPPORTUNITIES***
